ANDRUS ORDERS MELONES GATES SHUT

BROWN VETOES AB 2164, FOCUS OF THE STANISLAUS FIGHT GOES BACK TO CONGRESS

Reminder: HR 4223 is the bill that would put the Stanislaus from Camp Nine to Parrott's Ferry and parts of Rose Creek and the South Fork of the Stanislaus into the Federal Wild and Scenic River System.

TAKE ACTION NOW

Call your Congress member. Ask him to work for the passage of HR 4223. But whether he supports us or not at this time, ask that he contact Secretary Andrus immediately and urge the gates at New Melones to be opened, at least until Congress has a chance to act on the pending legislation. As Representative Fortney Stark (D-Oakland) said, "...if he fills the reservoir, the damage will be permanent and the area can never be reclaimed."

LATEST BREAKING EVENTS

The Situation Regarding ANDRUS:

The water in New Melones Reservoir is rising. It has reached the level of elevation 808 and is passing Parrott's Ferry Bridge. (Due to snowpack, the maximum level the reservoir can reach this year is 825 - 837.)

Secretary of Interior Cecil Andrus has been quoted as saying that he favors preserving the river, but his actions lately lend doubt to this statement. On June 6, Secretary Andrus ordered the gates closed at New Melones Dam and the water level raised in the reservoir up to the 818 foot level. In making his decision, Andrus said that "The archaeologists have done the necessary mitigation work well above that mark." He said that he was raising the impoundment level of the reservoir in order to help protect the region against possible electric power shortages by late summer. His third point concerned HR 4223. He said, "I do not want to inundate a white-water canyon if there is a serious chance that new Stanislaus River legislation will emerge from this Congress, but if there is not, I must follow the mandate of existing law."

Point by point FOR responses are as follows:

Andrus' staff has told him that the archaeological work done in the Stanislaus River Canyon was comprehensive and complete. The President's Advisory Council on Historic Preservation and the California State Historic Preservation Officer both protested that it was inadequate. Friends of the River along with the Sierra Club, Society for California Archaeology, Environmental Defense Fund, and other groups filed a lawsuit on Friday, June 13, against the Department of Interior, in Federal District Court, to stop the raising of the reservoir level. One of the claims in this suit is that the archeological work done in the Stanislaus Canyon was not thorough, nor was it adequately done. (See "Environmentalists Go To Court").

Regarding Andrus' statements on power, heads of the State Public Utility Commission and the State Energy Commission said Andrus was wrong. In a letter sent to Andrus from San Francisco, PUC Chairman John Bryson said the state's power reserve should be about 6.3 percent, not the 1.8

percent Andrus presented to the California Congressional delegation. State Energy Commission Chairman Rusty Schweickart sent a telegram to California congressmen saying the amount of additional electricity potential from New Melones "is insignificant" in comparison to available generating capacity and backup measures--such as sharing power between utilities. "The filling of New Melones is a water-rights and environmental issue, not an energy issue," he said.

On the issue of Congressional support, on June 13, Secretary Andrus was asked by 22 U.S. Congress members (via a letter presented by Parks and Insular Affairs subcommittee chairman Phil Burton,) to open the dam gates. The majority leaders of both the subcommittee, and the full committee on Interior and Insular Affairs assured Andrus that HR 4223 will be heard in Congress. Apparently this is not enough assurance for Mr. Andrus that "there will be serious floor action in both Senate and House this year upon the proposal to designate the river segment containing the canyon as a wild or scenic river." At this time, he plans to keep letting the waters rise.

Please call now urging your Representative in Congress to put pressure on Andrus to open the gates. It takes just a moment of your time. Thank you.

UPDATE ON THE BILL - HR 4223

Congressman Phil Burton, chairman of the subcommittee on Parks and Insular affairs announced Thursday, May 29 on a radio broadcast that he plans on passing legislation through both subcommittee and committee to protect the Stanislaus River Canyon. This action is expected to occur within the next 4 weeks. Now the opposition knows exactly what is going on and now more than ever Congressman Burton and your own representative in Congress need to know what their constituents feel. We need their support and they need ours. Things are moving up and down the state (See "Lobbying Visits..."). Make sure you are a part of it and spread the word. Get those people you have been hesitant to ask (your family, your closest friends, your business partner!) to act immediately. Read the enclosed Action Alert for ways to respond.

On June 11, Governor Brown vetoed AB 2164, Norm Water's bill to fill up New Melones. This veto is a great victory for the public, for the State, for New Melones Dam (which at the level of a moderate reservoir provides greater benefits), and for the Stanislaus River, the second most popular whitewater in the nation, and the deepest limestone canyon on the West Coast.

In spite of intensified lobbying efforts on behalf of the Stanislaus, on May 29 the state Senate passed AB 2164 by a vote of 26-6. This vote came following passage on April 10 in the Assembly by a vote of 44-32. It does not appear, however that Mr. Waters will be able to garner the votes needed for a veto override.

AB 2164 was a blatant attempt to torpedo HR 4223 the bill in Congress to preserve the upper Stanislaus Canyon. Because of Brown's veto, the focus of the Melones controversy shifts back to Congress and the consideration of HR 4223.

Many thanks to the people who traveled to the Capitol in Sacramento to help re-educate the legislature in river awareness. The task is not an easy one but it proved worthwhile when legislators changed their minds--convinced in the cause of the river.

UPDATE ON THE RIVER FLOWS

In a "normal" year, the peak snowmelt into the Stanislaus River occurs during the last week of May or first week of June. Such is not the case this year. Due to varied and unseasonally cold weather, there is still much snow above waiting to come down. Following several hot days into the 90's during the week of May 18, the river rose to more than 7600 cubic feet per second (cfs). But by that Friday night a cold spell had arrived, it was snowing at about 3,000 feet and the river flow quickly decreased to about 3,000 cfs where it stayed more or less for about 3 weeks. This has been good for the river as releases continued downstream and the reservoir continued to drop. Now it appears that summer has finally come to the Stanislaus. Hot days are back and the river is on the rise again. It is great to see that water coming down, but not to see the reservoir on the rise.

ADDITIONAL INFORMATION

Environmentalists Go To Court -

On June 13th, environmentalists and archeologists went to court to request a Temporary Restraining Order (TRO) which would direct Secretary of Interior Andrus to hold the reservoir at its present level. Thousands of people have written and called their Congress member urging support of this action. Plaintiffs in this case are the Environmental Defense Fund, Society for California Archeology, Friends of the River, Environmental Traveling Companions, and California for Preservation Action.

Grounds for the T.R.O. are threefold: 1) Under the National Environmental Policy Act (NEPA), the Water and Power Resources Service (WPRS) must define the service area for irrigation before the reservoir can be stored. Seventeen years after dam authorization, this service area has still not been defined. 2) According to the Historic Preservation Act, WPRS was required to conduct studies of the more than 600 archeological sites in the Stanislaus canyon. These studies have not been completed to the satisfaction of the State Historic Preservation Officer or the President's Advisory Council on Historic Preservation. 3) Under the California Water Code, the State Water Board must approve WPRS plan for operation of the dam before the reservoir is stored. The Control Board has not approved of the operation.

Violations of Federal and State laws must be stopped.

Fighting for Fish -

The Federal Fish and Wildlife Service predicts that, in the long run, the present release from New Melones Dam might "severely" harm downstream trout and salmon fisheries.

A minimum flow of 100 cfs in the lower Stanislaus is necessary to maintain downstream fisheries. That minimum flow is also required by the authorization for New Melones Dam. Yet at present, the release from New Melones Dam for fisheries is only 10 cfs.

Under the Fish and Wildlife Coordination Act, the operator of the dam, the Federal Water and Power Resources Service (WPRS), is supposed to consult with the Fish and Wildlife Service before altering the flow. The Fish and Wildlife Service is presently encouraging WPRS to significantly increase the release from New Melones Dam.

BEST FRIENDS OF THE DAM --- BFOD

<u>Update Report</u>: Best Friends of the Dam had its first rally at the capitol on May 28th. Kevin Wolf headed up the program which was attended by about 50 people and KXTV Channel 10. The highlight of the morning was a demonstration of flood control using two bathtubs to represent a moderate reservoir and a massive one. Bailing buckets of water were used to bring on the warm winter rains. They were emptied into the tubs showing how a partially filled reservoir provided better flood control. After the rally, everyone attended a meeting with Gray Davis from the governor's office. He was attentive, asked thoughtful, intelligent questions and was encouraging that the Waters' bill (AB 2164) would be veoted by Governor Brown.

Background - BFOD was formed a few weeks ago by concerned taxpayers who want the best use of the New Melones Dam. They define best use as best flood control, best assured net production of electricity, best downstream fisheries, and best way to stop the Federal Bureaucracy from bungling away more tax dollars. They demand no filling above Parrott's Ferry until contracts are signed that pay for the project.

SWAC --- STANISLAUS WILDERNESS ACTION COMMITTEE

Members of SWAC hit Washington with wheelchairs and all and made a major impression. A dozen people spent up to two weeks educating members of congress about disabled access to wilderness as well as other Stanislaus issues.

MAXIMIZING POLITICAL ACTION FROM RAFTING TRIPS

The commercial river guides of all of the companies running trips on the Stanislaus are continuing to get their passengers to write letters during their river trips. The response is growing daily as the guides are becoming more sophistocated in their knowledge of the economical and political issues as well as in activating the passengers.

The letter writing campaign has already spread to the American with many guides there linking the potential damming of that river with the New Melones Reservoir. Right now we are trying to spread the Stanislaus letter writing to the King, Kern, Eel, Tuolumne and every river around. If you work on one of these rivers or know someone who does, get your pens, paper, envelopes and Congressional zipcode lists and keep the letters and the rivers flowing.

NOTE: Recently one guide on a Tuolumne trip talked to a passenger about the Stanislaus. The passenger went home and informed his Congressman about the issue and as a result HR 4223 gained a new co-sponsor --- from Massachusetts! YAHOO! NOTE #2: A guide came off a Stanislaus trip and reports that of the people on his trip, 4 who own businesses will endorse the bill. Two of those businesses are contributors to Senator Cranston's reelection campaign. Also, the president of an electrical union local will get his local to endorse the bill. FANTASTIC!

AUDUBON - MAY 1980

For those of you who have not already done so, be sure to get your copy of the May 1980 issue of Audubon magazine. It contains an excellent article by John Mitchell entitled "Friend vs. Friend" on the Stanislaus controversy. The National Audubon Society has sent copies to the members of the California Congressional delegation along with the suggestion that they ought to get involved and help out in the fight to save this precious river resourse. Many thanks to Audubon for their efforts on behalf of the Stanislaus.

A diverse group of fifty people visited the Santa Rosa office of United States Congressman Don Clausen at 4:30 P.M. on May 29 asking for his support of HR 4223. Pro-Stanislaus delegations were simultaneously visiting the local offices of U.S. Congressmembers in 17 cities across the state, and 7 other visits occurred within days of May 29.

After a pre-meeting on the lawn of the federal building, bringing everyone up to date on the latest Stanislaus developments and on the approach to Clausen, a group photo was taken and the

group filed up to Clausen's office.

After introductions, Clausen's aide Pete Settles listened carefully as Ann Dwyer, John Farison, Vic Jenkins and others ably explained our position on the river, the dam and the necessity for controlling massive water development before the dam builders get their hands on the states' last dammable rivers on the North Coast, the area Mr. Clausen represents. Mr. Settles made no promises, saying the political implications of the vote were so important that Mr. Clausen would probably not make up his mind, or at least not announce his decision, until the day of his vote in the National Parks Subcommittee.

The afternoon's activities ended with a cup of wine or cider back out in front of the build-

ing and an agreement to return to Clausen's office on June 12 for follow-up.

One of the requests made at all of the meetings was for an appointment with the Congress member himself. But in Davis the FOR chapter was able to see their representative, Vic Fazio, on the first try. Mr. Fazio indicated that he would probably support the Stanislaus if it were included with an omnibus bill of wild river proposals from across the nation. Such a package is being put together now.

At Congressman Ron Dellums' office in Oakland, a group of more than 20 Stanislaus supporters were praised by aide Keith Carson for their organizing efforts. He said that Dellums fully sup-

ported our struggle and wanted to know what more he could do.

Congressional aides in Washington DC told FOR's Jennifer Jennings that they were impressed

by the groups of people and the streams of letters coming in supporting the Stanislaus.



Update

It has been a wild two weeks in the campaign for the life of the Stanislaus River Canyon. A chronology of some of the key events follows:

May 29: Hundreds of river supporters, in over 20 cities, visit the local offices of their U.S. Congress members and ask them to support H.R. 4223.

The State Senate in Sacramento passes a bill calling for massive enlargement of the reservoir.

June 5: Interior Secretary Cecil Andrus orders the further filling of the reservoir, but holds back on the decision of whether to stop at Parrott's Ferry or fill beyond that point.

A fifteen-member, pro-river lobbying team leaves California for Washington.

June 11: Governor Brown vetoes the state legislature's "Fill the dam" bill, and it fails to become law.

June 12: Second round of lobbying visits by Stanislaus supporters to California offices of U.S. Congress members.

June 13: Twenty-two U.S. Congress members ask Secretary Andrus to open dam gates. House Interior Committee leaders assure Andrus that H.R. 4223 will be heard in Congress.

Sierra Club, Friends of the River, Society for California Archeology, Environmental Defense Fund, and other groups sue the Department of Interior in Federal District Court to stop raising of the reservoir level.

Week of June 16: Cecil Andrus is deciding whether or not to continue filling the reservoir and flooding the canyon above Parrott's Ferry.



The <u>Smith River Management Plan</u> is out and, a bill is moving through the state legislature that will effect all our state Wild and Scenic rivers. OUR PLACE --- DON'T LET THEM TAKE IT AWAY

We believe we have made the point that storage of a moderate reservoir is the best use of New Melones Dam on economic grounds. But are all off us really fighting so hard just for the best use of a large Federal construction project?

The Stanislaus is part of the home, and part of the lives of many thousands of people. Are we a selfish elite? NO. Every week new people form a bond with the place. And the canyon has been part of peoples' lives for generations of Californians long before the dawn of history.

In this age when most of us live in our small corner of a crowded urban area and there is no frontier with "elbow room" into which we can spread out, the Stanislaus Canyon is a place we can and do go to find clear air and clean water, the adventure of journeying through unspoiled beauty, the opportunity to see the life of the planet much as it was created here. We aren't selfish. We invite anyone to come share and experience this place with us. We are not trying to take away anything, or any place, from anyone else.

But we will fight before we let anyone take our canyon place away from us and destroy it. They have destroyed enough of it already. There are 14 reservoirs on the Stanislaus and the one behind New Melones Dam is already the largest of them.
